Regulation

on Informing about Emergency Situations via SMS-Notifications

1. Terms and Definitions

ITS means Multilateral Trading Facility International Trading System Limited

Applicant means a Trading Member/ Clearing Member or another person willing to receive SMSnotifications on emergency situations.

Emergency situation means circumstances that, according to the estimate of ITS/ Clearing Organisation, have violated, violate or may violate normal serving of Trading Members/ Clearing Members in accordance with internal regulations of ITS/ Clearing Organisation.

SMS-notification means notification by ITS of Trading Members/ Clearing Members or other persons by way of sending them SMS-messages containing information on emergency situations.

SMS (Short Message Service) means method of communication, technology allowing receipt and transfer of short text messages (SMS messages) with the use of a mobile phone.

Sent SMS-Notification means relevant SMS-message transferred to the mobile network operator.

Authorised employees mean employees of a Trading Member/ Clearing Member or another person, to whose phone numbers ITS sends SMS-messages containing information on emergency situations.

All terms that are not defined in the Regulation shall have the meanings provisioned in the of Astana International Financial Centre (AIFC) Regulations and Rules and/ or ITS internal regulations.

2. General Provisions

2.1. ITS notifies Trading Members/ Clearing Members or other persons on occurrence/ change in status/ termination of Emergency Situations via SMS-notifications to Authorised Employees in accordance with this Regulation on Informing about Emergency Situations via SMS-Notifications (the Regulation).

2.2. A precondition for receiving of SMS-notifications is provision by the Applicant of information indicated in the Regulation under the procedure set out in the Regulation.

2.3. ITS bears no responsibility in case of non-delivery and/ or late delivery of the SMS-Notifications Sent.

3. Procedure for Information Provision by the Applicants

3.1. To Receive SMS-notifications, the Applicants that are Trading Members (Clearing Members) fill in and send to ITS following:

• SMS_INFO message compiled in accordance with the requirements of Annex No. 1 to the Regulation, in the form of an electronic document signed with the digital signature of the authorised person of the Applicant and sent with the use of the Document Exchange System to ITSKK@REPORT; or

• A message in paper format signed by the authorised person of the Applicant and executed in the form presented in Annex No. 2.

3.2. To receive SMS-notifications, the Applicants that are not Trading Members (Clearing Members) fill in and send to ITS an application in paper format executed in the form presented in Annex No. 2 to the Regulation. ITS may refuse to provide SMS-notifications to Applicants indicated in this clause without explaining the reason.

3.3. Applicant starts to receive SMS-notifications within the following time limits after receipt of ITS's response message on submitted message processing:

• By the next business day after receipt of ANSWER_SMS_INFO message executed in accordance with the requirements of Annex No. 1 to the Regulation, if the Applicant has sent SMS_INFO message in electronic format.

• By the fourth business day after receipt of a message on processing of the message executed in the form presented in Annex No. 2, if the Applicant has sent a message executed in the form presented in Annex No. 2 in paper format.

1. General Provisions

1.1. SMS_INFO message in CSV format is sent via the Document Exchange System to ITSKK@REPORT.

1.2. In case of successful processing of the SMS_INFO message, ITS sends its response in an ANSWER_SMS_INFO message.

1.3. In case of sending of an SMS_INFO message with the request type R (request of the list of Authorised Employees with indication of numbers), ITS replies with an ANSWER_SMS_INFO_RESPONSE message.

1.4. In case of changes in the information on the Authorised Employees, an SMS_INFO message with the request type D (delete entry) shall be sent regarding the said persons, and, if necessary, an SMS_INFO message with the request type A (add entry).

1.5. Only phone numbers with Russian or Kazakhstan code (+7) may be used to receive SMS-notifications.

1.6. Technical designations and notes:

- Coding: win-1251.
- ASCII horizontal tab (HT) (0x09) control symbol shall be used as a field separator in the lines.
- ASCII control symbols carriage return (CR) (0x0D) and line feed (LF) (0x0A) shall be used as line separators.
- MaxSize means the maximum number of symbols in a field.
- int means an integer.
- the following designations are used in M/O column:
 - M (mandatory) means mandatory field (an empty line is not allowed).
 - O (optional) means optional field (an empty line or "-" character is allowed).
